Todd has been in continuous practice at the Bar for over 38 years. He is predominantly a trial advocate with extensive experience across all jurisdictions in the Superior Courts of Australia, particularly in equity and commercial law. He regularly appears in the Court of Appeal, and in the Court of Criminal Appeal and the High Court of Australia.

He is a versatile Silk, having conducted hundreds of broad ranging commercial cases in trial and appellate Courts involving:

- contracts
- misleading, deceptive and unconscionable conduct
- estoppel
- breaches of fiduciary duty
- partnership, joint ventures, trusts and franchises
- fraud
- oppression of shareholders, director's duties and insolvent trading
- professional negligence
- deceased estates, including testamentary capacity and family provision

- real property, including easements and restrictive covenants

Todd has also conducted a wide range of common law, planning and environment, building and construction, defamation, insurance and criminal matters, both at first instance and on appeal. In crime, Todd has appeared for accused indicted on serious criminal offences including murder, fraud, sexual assault, acts of indecency and historical sex offences. He has also appeared in sentencing appeals.

Through his broad practice, Todd has developed expertise in litigation involving landslides, agriculture and prosecutions in Class 5 of the Land and Environment Court's criminal jurisdiction involving land clearing and contraventions of the *Water Management Act 2000* (NSW).

Todd has appeared as Counsel Assisting the Independent Commission Against Corruption at public inquiries (Operation Charity and Operation Hawker) and for the ICAC in various judicial review proceedings in the Supreme Court and appellate Courts. He has also represented affected persons at various public inquiries (including Operations Credo and Spicer in 2014 and Operation Misto in 2015). He appeared in the Royal Commission into Institutional Responses to Child Sexual Abuse in 2016.

Further, Todd has appeared in hundreds of mediations and is often retained to act as a Mediator in commercial disputes.

*Turnbull v Strange* [2018] NSWCA 157; 98 NSWLR 248 - subpoena seeking personal information (recorded telephone conversations) and the *Privacy and Personal Information Protection Act* 1998 (NSW).

*Ul-Hassan v R* [2018] NSWCCA 177 - sentence appeal for aggravated dangerous driving occasioning grievous bodily harm and section 21A(3)(a) of the *Crimes (Sentencing Procedure) Act* 1999 (NSW).

*Turnbull v Chief Executive of the Office of Environment and Heritage* [2018] NSWCCA 229 - sentence appeal for land clearing contrary to the section 12 of the *Native Vegetation Act* 2003 (NSW) and the parity principle.

*Boyd v Thorn* [2017] NSWCA 210; (2017) 96 NSWLR 390 - issue estoppel and the principle of privity of interest where a current party is not a party to earlier proceedings.

#### **Outside Court**

Todd was formerly the Head of Chambers of the Sixth Floor of Selborne Wentworth Chambers.

He is a passionate advocacy coach and was formerly the NSW representative of the Advocacy Training Council of the Australian Bar Association. Todd was the Course Director of the Appellate Advocacy Course in the Federal Court 2013 and 2014 and the Course Director of Advanced Trial Advocacy Intensive in the Federal Court in 2017, 2018 and 2023. He has taught the Advanced International Advocacy Course at Keble College, Oxford (twice), the Expert's Advocacy Course in Singapore, and the Appellate Advocacy Course in South Africa.

Todd is also the Chairman of the Board of Governors of The Pittwater House Schools and a director of Triathlon NSW Limited.

### As junior Counsel

Notably, Todd represented the families of the victims of the Thredbo landslide at the Coronial Inquiry into that tragedy that was heard over a period of 18 months. He conducted most of the nervous shock and compensation to relative claims, and most of the commercial claims that arose from the landslide in the Supreme Court of New South Wales against the State of NSW. He has since been briefed in cases involving geotechnical engineering issues.

He also appeared at the Coronial Inquiry into the Seaview Airlines crash near Lord Howe Island and represented the family of the pilot at the Coronial Inquiry into the Air Frontier crash in East Arnhem Land, Northern Territory.

As a commissioned officer in the Royal Australian Navy Reserve, Todd prosecuted and defended military personnel before Courts Martial and Defence Force Magistrates.
